**NATURE OF PROCEEDINGS:** Court Order

The court (Beckloff, J.) issued a judgment in favor of petitioner Geary J. Johnson, and against the respondent, the Unemployment Insurance Appeals Board, on July 25, 2022. Petitioner filed a motion to amend the judgment on September 13, 2023, which Judge Beckloff denied on January 24, 2024. Judge Beckloff then signed a judgment on February 26, 2024, denying petitioner's motion to amend and discharging the writ of mandate.

Petitioner Geary J. Johnson reserved a hearing date of April 26, 2024, for a motion for reconsideration. Petitioner did not file any motion, and the reserved hearing date does not afford statutory notice at this point. Therefore, the court cancels petitioner's reservation.

Petitioner filed a declaration of March 18, 2024. This appears to be in support of the motion for reconsideration that was never filed. Therefore, the court strikes the declaration.
