I have been a Kaiser member since around 2009-2019 and again 2022 to current. Around October 2024, I had asked Kaiser doctors for letters requesting a reasonable accomodation re employment and also housing. The primary doctor assigned to me at the time refused to provide such letters. I complained to Kaiser grievance procedure. In the meantime I learned that Kaiser has a procedure where a patient can received such letters if they fill out a form to the Medical Records department. I filled out such for in 2025 but medical records said the doctors in question refused to fill out such forms which would verify my medical ailments. I gave such letter

from a previous doctor so Kaiser would have an idea what the Kaiser letter should say. I also supplied suggestions for such letters. The latest doctors in question are Dr. Pathak, Dr. Jeffrey Siegel, and Dr. [REDACTED] have also refused to provide a letter requesting a reasonable housing accommodation. None of those doctors gave me a reason for their refusal. I feel this is discrimination under the Unruh act CC 51, 52 because of my race, Black, and because I have complained about a disability. I have been Denied full or equal accommodations, advantages, facilities, privileges, or services by a business establishment- including both private and public entities. This is retaliation because I complained.
